**ELECTION OF EXECUTIVE COMMITTEE FOR THE YEAR 2025-2026**

1. The term of the Executive Committee shall be of one year.
2. There shall be election for 16 seats of Executive Committee Members. 8 nos. of seats will be from individual / Professional life members of NMA and AIMA – NMA members. Remaining 8 members shall be from Organizations, Companies, Firms Industries that is Private, Public, and Joint Government and Co-operative sectors organizations which are engaged in the manufacturing activities or service activities which include Educational Institutions. In case there are no

sufficient nominations representing Organizations, such unfilled positions shall be treated as General.

3. Shri Surinder Mohan is the Returning Officer for this election. (Mob no. 9871799434)
4. The membership renewal of yearly Organization Members/ Individual Members have become due wef 01-04-2025. Only such members shall be eligible to participate in the election process and file their nominations who have paid their subscription and renewed their membership in these categories for the year 2025- 26 upto 31<sup>st</sup> May 2025.
5. Members seeking election may go through the election procedure and schedule (Annexure-1) forwarded herewith. The election schedule and the election procedure and the criteria of eligibility for contesting election shall be notified on the notice board of NMA and NMA Website also on 22<sup>nd</sup> May 2025.
6. The nomination forms, Individual / Professionals Members duly proposed by another member should be sent to NMA Office so as to reach latest by 2<sup>nd</sup> June 2025 up to 5PM. One member cannot propose more than two candidates. (Nomination form enclosed.)
7. Organizations sponsoring their candidate seeking the election to the Executive Committee may please note that a letter on their letter pad for nominating / sponsoring them by their organization should invariably have the consent of the Nominated Individual. These nominations are to be received in NMA office latest by 2<sup>nd</sup> June 2025 up to 5PM.
8. Those who are desirous of contesting this election may get nomination forms (Individual or Organizational)/duly filled in and send it to us on or before 2<sup>nd</sup> June 2025. Nomination forms can also be down loaded from NMA website.
9. If the Nomination of candidates in Individual category or Organization category as the case may be are more than the 16 Members of Executive Committee (Post Required) in that case election process shall be held in NMA House and ballot papers which shall be sent to the members in NMA two Envelopes and completed/ticked ballot paper may be submitted in NMA Office on/or before 26th June 2025 through speed post/ courier services by 05:30 PM.

10. Members are requested to participate in the Election as per above schedule and caste their vote in NMA House as per schedule enclosed.
